WHEREAS, the Sheriff has determined a need for relief in the jail kitchen. Due to staffing issues and resignations, the lack of interest in the current vacant positions, the Sheriff and Jail Administrator have elicited and received a contract proposal from Trinity Services Group to take over operations and management of the jail kitchen. Trinity currently operates the kitchens in 19 correctional facilities in New York State; and

WHEREAS, our 2024 budget for food, supplies, labor, and fringe are established to be \$264,647. The resolution request is option 2 as noted in current contract proposal to reflect Trinity staff and one current full-time county employee. Trinity cost by contract is \$220,643, current full-time staff position cost of \$41,528.22 combined for total cost of \$262,171.22, a cost savings of \$2,475.78;



WHEREAS, the Coast Guard's history began on August 4th, 1790, when a resolution of the Continental Congress authorized the construction of ten vessels to enforce federal tariff and trade laws and to prevent smuggling. Known variously through the nineteenth and early twentieth centuries as the Revenue Marine and the Revenue Cutter Service, the Coast Guard expanded in size and responsibilities as the nation grew; and

WHEREAS, the service received its present name in 1915 under an act of Congress that merged the Revenue Cutter Service with the Life-Saving Service, thereby providing the nation with a single maritime service dedicated to saving life at sea and enforcing the nation's maritime laws. In 1946 Congress permanently transferred the Commerce Department's Bureau of Marine Inspection and Navigation to the Coast Guard, thereby placing merchant marine licensing and merchant vessel safety under their purview; and



WHEREAS, August 10, 1961 is thought to be the first day that the herbicide and chemical defoliant Agent Orange was sprayed in Vietnam; and

WHEREAS, Agent Orange Awareness Day marks the anniversary of the substance being sprayed in Vietnam for the first time and is meant to raise awareness of the effects of the herbicide used during the Vietnam War. Not only does Agent Orange Awareness Day bring honor to Vietnam Veterans, it also brings to light the continuing toll of Agent Orange exposure; and

WHEREAS, Studies estimate over 300,000 U.S. Veterans died from exposure to Agent Orange from 1962 to 1971. The Agent Orange Act of 1991 responded to the many health concerns expressed by Vietnam Veterans in relation to herbicide exposure by requiring the VA to presume that all Veterans who served “ boots on the ground” in Vietnam were exposed to Agent Orange; and

WHEREAS, in 2019 Congress passed the Blue Water Navy Veterans Act which extends VA benefits and disability compensation for Agent Orange exposure to Blue Water Navy Veterans who served in Vietnam and the offshore waters; and

WHEREAS, The Vietnam War ended 49 years ago, yet the effects of Agent Orange are still felt today by Vietnam Veterans, and their families. The Veterans Administration considers more than 15 diseases to be caused by or linked to exposure to Agent Orange. The list includes 8 types of cancer, Parkinson’s Disease, ALS or Lou Gehrig’s Disease, Diabetes and Birth Defects in children of Veterans who had exposure to Agent Orange; and

WHEREAS, the Yates County Legislature seeks to honor these individuals who have paid a high price for our freedom while serving in Vietnam;

NOW, THEREFORE, BE IT RESOLVED, that the Yates County Legislature asks all citizens of Yates County to join them in bringing an increased awareness to the ongoing toll of Agent Orange; and be it further


