NEW YORK STATE OFFICE OF CANNABIS MANAGEMENT ISSUES EXPANDED PRODUCT RECALL ON INDOGRO LLC CANNABIS PRODUCTS

*After Identifying Inputs from Unlicensed Source, OCM Issues Expanded
Recall with Additional Lots*

*Consumers Urged to Check Product Lot Numbers and Discontinue Use
of Products Immediately*

ALBANY, N.Y. — [The New York State Office of Cannabis Management \(OCM\)](#) has expanded [a recent product recall from June 11, 2025](#) involving multiple adult-use cannabis products manufactured by IndoGro LLC (IndoGro). [Consumers should be advised that this recall is a precautionary measure.](#) The Office of Cannabis Management has not received any reports of adverse effects caused by the consumption of these products. Investigation into this matter is ongoing.

Consumers in possession of products affected by the initial and this expanded recall are urged to immediately discontinue use and follow the [disposal guidance on the OCM's website](#). A full list of recalled products and affected lot numbers is available at cannabis.ny.gov/recalls.

The initial recall, issued on June 11, 2025, stemmed from concerns about invalid testing results submitted by a former OCM-permitted laboratory. Upon retesting, regulators found a total of nine (9) product lots were found to contain unallowable levels of pesticides and were deemed unsafe for consumption. Following further investigation, OCM has issued an expanded recall covering 28 additional product lots produced by IndoGro. These additional lots were found to have been made using material sourced from

an out-of-state entity who does not possess a license issued by OCM — a violation of Cannabis Law and public health standards. As such, these products are considered adulterated and pose a potential risk to consumer health and safety.

If you are a consumer who purchased any product lots produced by IndoGro LLC, indicated in the table below, and you wish to return the recalled product, please contact the retail dispensary where you purchased these products. You can return a recalled product even if you have opened it.

These cannabis products are being sold through licensed cannabis adult use dispensaries throughout New York State. Dispensaries and distributors must cease distribution and sales of the affected products immediately. The products may go by names that include, but are not limited to, Indi, Grow by Indi, Our Creation, and Grow with Us, and will feature the INDI logo pictured below.

The presence of unallowable pesticides in cannabis products constitutes a testing violation under **9 NYCRR §123.6(h)**, for which OCM may issue a recall pursuant to **9 NYCRR §133.4**. Additionally, the licensee transported, produced, and sold products made using cannabis sourced from an out-of-state entity who does not possess a license issued by OCM—constituting a direct violation of **Cannabis Law §69(1)**. These actions also violate **Cannabis Law §§125(7), 125(10), 136(2), 136(3), 136(4)** and **9 NYCRR §§123.10(g)(7), 123.10(g)(11)(iii)**, placing cannabis consumers and the broader public at risk. As a result, the Office has expanded the recall under its authority pursuant to **9 NYCRR §133.4**.
